GRHC Hosts Landlord Training on New HUD NSPIRE Inspection Standards

To help our landlord partners become familiar with the new HUD National Standards for the Physical Inspection of Real Estate (NSPIRE), during mid-January the Grand Rapids Housing Commission (GRHC) hosted an NSPIRE training designed specifically for rental property owners and managers who participate in federal housing voucher programs. Held at GRPS University, the training was conducted by Housing Choice Voucher inspections expert Morgan Petragallo, a trainer with well-known housing industry consulting group Nan McKay and Associates.

Eighty landlords and GRHC staff participated in a wide-ranging presentation that covered how NSPIRE differs from Housing Quality Standards (HQS) regulations, inspectable areas, types of inspections, health and safety determinations, and more.

Attendees also had an opportunity to get answers to their questions about NSPIRE. The GRHC started phasing in the new HUD inspection standards last fall, and full implementation got underway March 1.

These draft plans lay out strategies, goals and objectives designed to help us optimize programs and services to meet evolving community needs related to such issues as rising housing costs, gentrification pressures, changing demographics, racial inequities and a challenging political environment.

Over the past year, our agency gathered input from a wide range of stakeholders about needs, emerging trends and the GRHC's role going forward. This included getting perspectives from the GRHC board and staff as well as residents, neighborhood groups, elected officials, funders, affordable housing developers, and service providers and other partners.

Many thanks to the staff and Housing Commissioners who contributed within our strategic planning work group, and to all of the staff, board members, partners and residents who participated in our strategic planning survey and/or public input sessions. We hope you will review the drafts linked in the public hearing announcement below and continue to provide input that will help us to refine our plans and deliver the most effective programs possible to the families we serve.

PBV-Supported Samaritas Development Opens in Spring Lake Township



GRHC Executive Director Lindsey Reames represented our agency at an early February ribbon cutting for The Landing at Spring Lake, a \$16.4 million affordable rental housing property developed by Samaritas. Located at 734 E. Savidge Street in Spring Lake Township, the 53-unit development includes eight units that are supported by Section 8 Project-Based Vouchers (PBVs) awarded by the GRHC. Families in the assisted units will typically pay 30 percent of monthly household income on rent, with the GRHC's PBV Program making up the difference between that amount and the established rent for the unit.

The Landing at Spring Lake serves households earning 30 to 80 percent of Ottawa County's area median income. Through a partnership with the Little River Band of Ottawa Indians, eight units are reserved for tribal members. Amenities include community spaces and a digital learning hub.



During 2022 the GRHC made 23 undeveloped parcels purchased from the City of Grand Rapids years ago available to partner organizations planning to build affordable housing; all lots were offered at the original purchase price of \$2,000.

Habitat for Humanity of Kent County bought five lots with the goal of constructing affordable single-family homes. In late January ten Housing Commission staff had the honor of lending a hand with finish work at the Habitat home under construction at 362 Fox Street SW.

"There is a critical need for affordable housing in our area, and it is extremely gratifying to have the opportunity to support Habitat for Humanity's efforts to make homeownership possible for low-income households," noted GRHC Executive Director Lindsey Reames, one of the volunteers lending a hand.
